**ELIGIBILITY:** Open to all swimmers currently registered with USA SWIMMING and Alaska Swimming. Signature of a club official or coach shall make verification of athlete's membership in USA SWIMMING on the enclosed athlete verification form. Penalties for falsifying membership shall be imposed according to current Alaska Swim Guide.

**RULES:**

1. Current USA SWIMMING and Alaska Swimming rules shall govern this meet.
2. All events will be swum as a timed final.
3. This will be a pre-seeded meet.
4. No swimmer check in is required, however, coaches will check in with the meet director during the coaches meeting prior to the start of the meet.
5. No team or individual high point scores will be kept.
6. USA SWIMMING and Alaska Swimming Warm-up guidelines will be enforced.

**SCRATCH RULES:** Scratches for events shall be delivered to the Meet Director on the attached scratch form no later than 9:30 a.m. on the day of the meet.

### ENTRY INFORMATION:

1. All entries may be submitted on Master Entry form/recap. sheet. (sample attached) or,
2. On 3.5" disk using the Hy-Tek software COMMLINK file using the "Build" option along with the following printout:
  - a) Send a Team Manager "team entry report" by person
  - b) Send a Team Manager "team meet fees report"
  - c) Send a Commlink file "list swimmer times report"
3. RELAY ENTRIES: Include Relay information by either method plus list relays on Relay Recap Sheet.
4. Swimmers are limited to four (4) individual events and one (1) relay event.

### ENTRY DEADLINES:

1. Entries must be postmarked or hand delivered no later than **Monday, February 15, 2010**. Entries must be accompanied by payment and USA SWIMMING verification form or will not be accepted.
